If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. In-network <a href="#">preventive care</a> & immunizations, office visits, <a href="#">diagnostic test</a> , in-network <a href="#">prescription drugs</a> , emergency room visits, <a href="#">urgent care</a> facility visits, in-network childbirth delivery & office visits.
